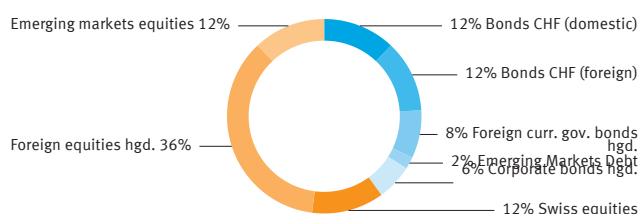
Avadis Asset Growth

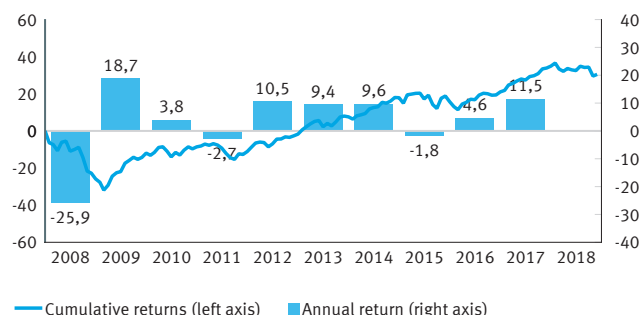
