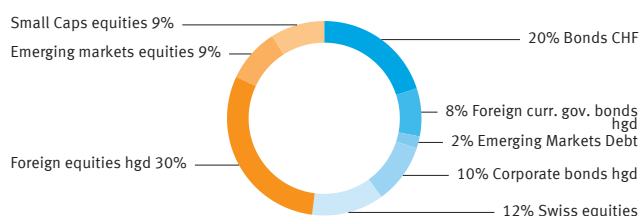
Investment goal

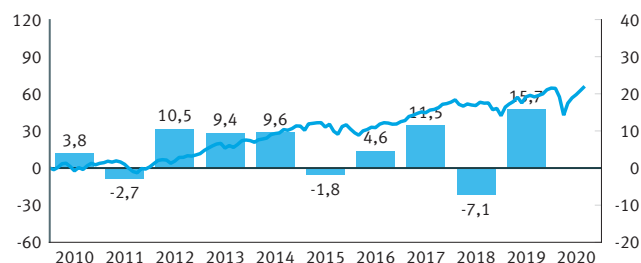
